
**Resolution**  
**San Diego County Public Law Library**


The Political Reform Act, Government Code Section 81000, et seq., requires state and local government agencies to adopt and promulgate conflict of interest codes. The Fair Political Practices Commission has adopted a regulation, 2 California Code of Regulations Section 18730, which contains the terms of a standard conflict of interest code. It can be incorporated by reference and may be amended by the Fair Political Practices Commission after public notice and hearings to conform to amendments in the Political Reform Act. Therefore, the terms of 2 California Code of Regulations Section 18730 and any amendment to it duly adopted by the Fair Political Practices Commission are hereby incorporated by reference and, along with the attached "Exhibit A" in which members and employees are designated and disclosure categories are set forth, constitute the conflict of interest code of the San Diego County Law Library Board of Trustees.

Pursuant to Section 4 of the standard code, designated employees shall file statements of economic interests with the agency. Upon receipt of the statements of the designated employees, the agency shall make and retain a copy and forward the original of these statements to the Clerk of the Board of Supervisors, County of San Diego.

The adoption of this resolution replaces the previously adopted Conflict of Interest Code of the San Diego County Law Library Board of Trustees.

### **Category 7. Reportable Investments for Law Library**

(See Government Code Section 82034)

A designated employer in this category shall disclose only investments in any business entity, which within the last two years has contracted with or in the future foreseeable may contract with the Board of Law Library Trustees to provide services, supplies, materials, machinery or equipment to the San Diego County Public Law Library.

### **Category 8. Reportable Investments for the Law Library Trustees**

(See Government Code Section 82030)

A designated employee in this category shall disclose only that reportable income which is derived from a source which within the last two years has contracted with or in the future foreseeable may contract with the Board of Law Library Trustees to provide services, supplies, materials, machinery or equipment to the San Diego County Public Law Library.
